Frequently Asked Questions

How did SCOAR get started?

SCOAR got started in 1973 as The Business Roundtable-South Florida Chapter. In 1974, a similar group, the Florida Business Roundtable was incorporated in Tampa, primarily as a central Florida organization. In 1975 the two groups merged and become the Florida Business Roundtable, a statewide organization. In 2002, in response to the formation of CURT, formally the construction arm of the Business Roundtable, the Florida Business Roundtable changes its name to FCURT, the Florida Construction User Roundtable. FCURT operated in cooperation with the South Georgia Local User Council. In 20211, due to membership and member business activity interests beyond Florida, the organization changed its name to the Southeastern Construction Owner and Associates Roundtable, Inc. (SCOAR).

Is SCOAR part of CURT?

SCOAR is one of 26 local user counsels of the Construction User Roundtable (CURT). We share common interests and beliefs. Many of our members are also members of CURT.

What are the member benefits?

Member companies can have up to three members attend programs meetings free of charge; access to the Member's Portal, Speaker Presentation Library, Member Directory and Committee Pages; your company logo in the SCOAR website; discounts on displays at meetings; opportunities to present Sponsor Solution; participation in meetings and committees; networking and relationship building opportunities; and access to select CURT Publications and Resources.
